The user is a person who registers the dog and pays the registration fee through the website of the online registration of exhibitions. (hereinafter referred to as the User)

## CONCLUSION OF THE CONTRACT

The contract between the Organizer and the User for attending the event is considered concluded in moment when entry has been made. By entering a dog User accepts the Privacy policy, terms and conditions of use.

Applications are open on April 24, 2024. and last until September 24, 2024. with the possibility of extension up to 7 days before the event.

## PRIVACY

We respect your privacy and we want to maintain your confidence in our handling of any data and information that is collected during your visit to our web site.

We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so.

You may request details of personal information which we hold about you under the Data Protection. We will promptly correct any information found to be incorrect.

## DATA EXCHANGE

Upon confirmed registration to a show, we will transfer all registration information to the show organizer and/or the national Kennel Club of the organizer. The registration information includes information about the dog(s) (name, pedigree, birth date, parents, copies of pedigree and other certificates, etc), the dog's breeder and co-owner (names) and owner (name and contact information), the registration (registration time, class, registration fee).

By agreeing to the Terms User agrees that the data provided can be automatically processed. The organizer can use them in order to enter a dog and for all other activities related to participation in a dog show. The User declares that all information given about himself is true and complete, that is legally competent, authorized user of the credit card and that there are no known barriers to entering his dog through the website entry. According to a statement on the privacy and security of data, ENTRY collects only basic data necessary for the fulfillment of obligations.

## IDENTIFICATION

Use of this website is subject to Republic of Croatia law. These terms and conditions will be governed by and interpreted in accordance with the law of Republic of Croatia. You agree to submit to the exclusive jurisdiction of the Croatian Courts in relation to any claim, dispute or matter arising out of or relating to the use of this website.

## ORDER AND BILLING OF SERVICES

Entry of a dog is accomplished by selecting the desired show which is held at a specified time. Exhibitor is making login as a registered user.

All our prices are indicated inclusive of tax (all taxes included) and in euros.

Bank charges may be different depending on the country of destination. The User pays the transaction costs.

There are two different payment options for registering your dogs.

### 1. Payment by Credit Card:

As part of a registration, the customer's card number is not kept on our servers, which guarantees confidentiality.

### 2. Payment by bank transfer: IBAN HR8023600001102700556

The method of payment by bank transfer causes a delay between the payment at registration and its registration on the website account.

Plan to anticipate your registrations and payments to avoid cancellation for lack of payment within the time limit.

Payment is considered made in the time of automatic billing from User's selected credit card or by visible bank transaction on a Organizer's account. User receives on e-mail address confirmation of a dog entry. Application of the dog can be made until the last entry deadline expires. All payments will be effected in EUR (Euro). When paying by credit card or by bank transfer, transaction costs and / or interbank transaction costs are not included in the price.

## REFUNDS

Withdrawals received before 24.09.2024. or deadline of a show may be eligible for a refund of the paid amount. Refunds will be issued only by proof of written notification accompanied by either a veterinary or medical certificate. A 10€ Administration Fee for each dog will apply to refunds. Refund requests submitted after 24.09.2024. or after the deadline of the show are not possible in any case.

If the Organizer cancels the event due to force majeure (flood, earthquake, epidemic, pandemic ..) Users will be refunded paid money reduced by the amount of 10 € administrative costs, and within deadlines that will be consistent with the state and capabilities of the Organizer with regard to new circumstances. The refund period will be 12 months from the date of cancellation of the event.
